Re: Termination of Agreement Regarding *Brass*

Dear Mr. Soued:

We represent Martin Wallace in copyright and related intellectual property matters. He has brought to our attention the contract with a predecessor of your company regarding the game *Brass*, dated February 26, 2008 ("Agreement").

Mr. Wallace has terminated the Agreement by his letter to you of July 21, 2015 (copy attached). That termination was effective immediately in view of your company's consistent failure to provide quarterly statements of account pursuant to Article 7 of the Agreement, which requires statements of the number of units sold, net sales, and royalties owed. Deposits to bank accounts and recent public postings on BoardGameGeek.com do not substitute for formal statements to the licensor.

Furthermore, your company failed to provide the required ten (10) sample units of the White Goblin version of the game.

All rights to *Brass* are reverted to Mr. Wallace, including copyrights, trademark rights, and rights of publicity.


